Notice of Termination (NOT) Request Information

NOT Requirements:

- ❖ Complete final stabilization on all disturbances due to construction activity (*70% density, uniform on all disturbances*)
- ❖ Remove debris from impervious surfaces, catch basins, BMP's, waterways, etc.
- ❖ Clean any permanent treatment systems and return to design capacity
- ❖ Provide documentation that infiltration BMP is functioning as intended (infiltration test)
- ❖ Remove all temporary erosion control devices, stockpiles, construction waste
- ❖ Provide Engineering Department with as-built drawings for all private stormwater and sanitary systems including permanent stormwater BMP's (*except single family residential*)
- ❖ Provide Engineering Department with final lot survey (*except single family residential*)
- ❖ Pay all non-routine inspection costs or any other fees to the City of Owatonna

Additional Information:

- ❖ Your site will be inspected by the City to ensure compliance
- ❖ You will receive confirmation of the NOT being accepted
- ❖ A completed NOT does not qualify for termination of any permits other than the City's Grading/ ESC Permit
- ❖ A completed NOT does not exempt any long term BMP maintenance
